Important Rules and Regulations

- All tuition is due by the 1st of the month regardless of holidays or absenteeism.** Tuition is based on a yearly rate and is split into 10 monthly payments (September thru June). Any payments **not received** by the due date will be assessed a **\$10 late fee**. If tuition falls behind by 2 months the student will not be allowed to return to class until payment arrangements are made. All returned payments will be assessed NSF fees plus \$10.00 studio fee. **Private lesson tuition** must be paid at the first lesson of the month in order for them to attend their lesson.
- Students must follow the studio dress code that is listed in our brochure. If they fail to follow the dress code they will not be allowed to participate in class. **Students are not allowed to wear their street shoes into the studio rooms. They must be kept with their jackets in the lobby.**
- There are no reductions given for missed lessons. All classes canceled by the studio will be made-up during the season.
- If any student/parent causes any damage to studio property they will be liable to pay for the damages.
- Costume payments are **non-refundable**. A \$20.00 late fee will be charged for any overdue costume payments.
- Children under age 10 **MUST** be accompanied by a parent/adult chaperone when being dropped off and picked up from dance class.
- Studio 5678 has the right to use any students photo for marketing purposes.
- All students are required to have FUN while learning the art of dance.
- COVID 19 Release:** I assume all risks that I and/or my child(ren) may be exposed to or infected by COVID-19 as a result of participating in lessons at Studio 5678. I understand the risks of exposure or infection may result from the actions, omissions or negligence of myself, my child(ren), Studio 5678 staff, volunteers, other students/parents and I acknowledge that such risks are known to me. I waive and release Studio 5678, Janet Keppel & all other Studio 5678 employees/volunteers from all claims, suits, liability, costs and expenses of any kind resulting from illnesses, injuries or damages to myself or my child(ren) sustained during or related to my child(ren)'s participation or involvement at Studio 5678.

- If you remove your child from our dance program after our recital costume invoices are generated, you are liable to pay for all shipping fees that were allocated to your invoice.
